2. Introductions were completed utilizing an alphabetic approach based on attendee’s first names. This takes some time but gives everyone an opportunity to know when they should chime in, hopefully without talking over others. Some people choose not to utilize the Zoom video but most attend the meeting with both audio and video. People seem to be getting more familiar with various features such as mute, chat, and sharing screens.
3. A review of the agenda was completed. Information regarding the success of our March meeting and the large increase in attendance was shared with attendees. The group engaged in conversation regarding ongoing challenges posed by COVID-19, of which some of those challenges affect events such as the quarterly state FYSPRT meeting and the WISE Symposium currently scheduled for June and July respectively. Attendees were informed of the new Salish regional FYSPRT website www.salish-bhaso-fysprt.org and encouraged to visit the site for a tour. And, attendees were introduced to the new Salish Regional FYSPRT Youth Tri-Lead, Justice Heil. Justice shared only a little as this is her first meeting in this capacity, but it was encouraging to know that Salish FYSPRT once again has a Youth Tri-Lead voice.
4. Karen Kelly, Project Director from Washington State Community Connectors (WSCC) provided an excellent presentation about what “Genuine FYSPRT Engagement” consists of. She provided specifics relating to both Genuine FYSPRT Family Engagement, and,

Genuine FYSPRT System Partner Engagement. Her PowerPoint presentation (a) was interesting and she was able to share parts her own lived experience in her delivery. Karen encouraged questions and sharing from attendees and offered multiple opportunities for Q&A throughout the presentation. At conclusion Karen provided a site for individuals to complete a survey (b) and offer feedback.
